**OUR FINANCIAL/ INSURANCE POLICY:**

The patient portion is set by the insurance company. It is ultimately your responsibility to see that your bill is paid in full.

All co-pays and deductibles are due the day of treatment. If your deductible has not been met at the time of your appointment **we will collect a portion.**

**LATE ARRIVALS, NO SHOW AND CANCELLATIONS**

Our providers do their best to run-on-time. We require you check in 15 minutes early for all appointments. If you are 10 minutes or more late, you may be rescheduled. All cancellations should be made no less than 48 hours prior to your appointment, please do not leave messages on the weekends for cancellations. For emergencies, we do have an after hours answering service which you can reach by calling our main office number. Office appointments which are cancelled with less than 24 hours notification may be subject to cancellation fee of \$1 per minute reserved for your visit. Repeat problems with making your appointment time may require a non-refundable deposit to reserve time for you.
